



Privacy Policy for Quirky Plush Co.

Quirky Plush Co. (“we”, “our”, “us”) operates as a subsidiary of Jeron Osg, a media and creative company. We are committed to protecting your privacy. This Privacy Policy outlines how we collect, use, and safeguard your personal information when you visit our website (“Site”), hosted on WordPress (via DreamHost) and powered by WooCommerce, and when you interact with our services.

1. Information We Collect

We collect the following types of information:

A. Information You Provide

- **Account Information:** When you create an account or make a purchase, we collect your name, email, address, billing address, shipping address, and phone number.
- **Payment Information:** Payment details such as credit card information are processed securely by our payment gateway provider (WooPayments via Stripe) and are not stored on any Quirky Plush Co. or Jeron Osg servers.
- **Communication:** Information you provide when contacting us through forms, email, or chat.

B. Automatically Collected Information

- **Device Information:** We collect information about your device, browser and operating system.
- **Usage Data:** Details about your interactions with our Site, such as pages viewed, time spent, referring URLs.
- **Cookies and Similar Technologies:** Cookies help us improve your browsing experience and analyze Site performance (See “Cookies” section below).

2. How We Use Your Information

We use your information to:

- Process and fulfill your orders.
- Communicate with you about your orders, updates, and promotional offers.
- Improve our website functionality and user experience.
- Comply with legal obligations and enforce our terms.
- Personalize your shopping experience and provide product recommendations.

3. Sharing Your Information

We do not sell or rent your information. However, we may share your information with:

- **Service Providers:** Third-party vendors who help us operate our Site, such as payment processors, shipping carriers, and analytics tools.
- **Legal Obligations:** Authorities or other entities when required by law or to protect our rights.
- **Business Transfers:** In the event of a merger, sale, or transfer of assets within Jeron Osg or its subsidiaries.
- **Independent Contractors:** Some data may be shared with independent contractors in order to fulfill orders.

4. Cookies and Tracking Technologies

Our Site uses cookies and similar technologies to:

- Enable essential website functions (e.g., keeping items in your cart).
- Remember your preferences.
- Analyze website traffic and performance.

You can manage your cookie preferences through your browser settings.

5. Your Rights

8. Third-Party Links

Our Site is not intended for children under 13, and we do not knowingly collect personal information from them. If we become aware that we have inadvertently collected such information, we will take steps to delete it.
